Summary of Public Participation Section

Parish Council Chairman, Cllr. Antony Jones opened the meeting and invited participation from the public.

Report from Wiltshire Council

Wiltshire Councillor, Allison Bucknell.

One main point in Wiltshire is the cost-of-living crises. The wellbeing hub has been re-opened for those who are having trouble sourcing local support. Local organisations are being asked to see if they could provide a little extra support to provide a warm space for people.

Changes now have taken place in Bradenstoke with change of speed limits. This information is being circulated as and when appropriate.

No information has been provided yet regarding the outcome of the appeal of the Land at Webb's Court and still awaiting a date for the planning committee hearing for the Clack Hill Yard application.

Finally, the Bradenstoke Solar Farm Committee Benefit Fund AGM was held week commencing 31 October 2022. The Committee agreed to offer grants of £1500 to the Community Spaces and emails have been sent to 5 Community Spaces within Lyneham and Bradenstoke. It is hoped that a response will be quickly received.

MOD Lyneham Report from Major Vernon Gadsby

1. Thanks to all who came and supported the Bonfire Night on 2nd November.
2. 13th November there will be an event in the REME museum car park for a service of remembrance. There will be a parade on the day, but the MOD will also be supporting Sutton Benger, Calne and Bradenstoke. At REME Lyneham the public is notified that car parking spaces will be limited.
3. There will be a series of small Christmas events starting on the 3rd that will see some traffic in and out of the MOD site. Nothing that should see any additional stress in the local community.
4. The Christmas stand down will begin on the 17th of December 2022 with a series of units now at MOD Lyneham you will see disbursements going for the Christmas leave across the county.
